By pledging a nominated amount to be deducted from your pre-tax pay, you're helping people with disability live life to the full and make the most of every opportunity.

How are funds used?



Your regular donations provide the services and supports that help our most vulnerable Australians live their best life.

The introduction of the National Disability Insurance Scheme (NDIS) is an important step for people with disability, but it only funds reasonable and necessary supports.

Your donations cover those items the NDIS is not covering. Donations contribute towards things that make possibilities a reality – such as virtual reality kits, iPads to provide vital learning, houses for people with disability to call home, and literacy aids such as notebooks and pens.



How does it work?

Making a charitable donation at work saves you time and money.



The tax benefit is received immediately without having to wait until the end of the tax year or collect receipts.

You can change or cancel your donation at any time by contacting your Payroll team.

Workplace giving does not affect your superannuation or payroll tax calculations and is not counted as a fringe benefit. A workplace giving donation reduces your PAYG liability without decreasing your gross income.

If your organisation has chosen to match donations, your contribution means that Endeavour Foundation will receive double the amount of your pledge towards supporting people with disability.

It costs you less when you donate pre-tax

When you give \$5.00		
Workplace giving (not matched by employer)	Pre-tax giving costs you only \$3.40*	...but Endeavour Foundation receives \$5.00
Workplace giving (matched by employer)	It costs you \$3.40* + \$5.00 (Employer donation)	Endeavour Foundation receives \$10.00

*Applying tax rate for income between \$37,001 and \$80,000 per annum @ 1 July 2017.
